Entire Agreement; Modifications; Binding Effect.** This written Agreement contains the sole and entire agreement between Kansas K-9 Karma Animal Advocates Inc. and you, and supersedes any other agreements between you and K-9 Karma Animal Advocates Inc with respect to the subject matter of this Agreement. No modifications of this Agreement will be valid unless in writing duly signed by both you and us. This Agreement will be binding on our and your respective heirs, personal representatives, executors, successors and assigns.
