If I enter into activities of a political or controversial nature, I am doing so as an individual, separate from K-9 Karma.
- 3) I understand that as an individual, I cannot enter into agreements for the organization; any such activity will be forwarded to the Board of Directors.
- 4) I accept full responsibility for expenses incurred by myself as a volunteer for K-9 Karma. Although I may be reimbursed by K-9 Karma, I must have prior approval from an officer of the Board of Directors, as well as the necessary documentation and receipts.
- 5) I will always remember that I represent a non-profit organization and cannot profit from any activity related to the organization.
- 6) I understand that K-9 Karma cannot guarantee or be held responsible for the health, behavior or temperament of any dog I may handle.
- 7) I understand that if an applicant is new to Rescue, K-9 Karma requires a period of mentoring by an established K-9 Karma member.
